

# Terms & Conditions of Participation

The competition made available on The MotherHoodThe MotherHood's website [www.TheMotherHood.com](http://www.TheMotherHood.com) and which is defined in these Terms and Conditions (hereinafter the 'Competition') is hosted by The MotherHood Ltd. (a company registered in UK).

These Terms shall be binding on You when You enter and participate in the Competition. Entry and participation in the Competition by You shall be deemed an unconditional acceptance by You of all these Terms and Conditions.

## Participation

1. To enter and participate in the Competition You have to fill out the Competition form available through the designated tab on The MotherHood, The MotherHood's website [www.WestLondonMum.co.uk](http://www.WestLondonMum.co.uk) and /or register through on The MotherHood The MotherHood's Facebook page and/or Twitter or Instagram.
2. Participation in the Competition is free of charge and voluntary.
3. By entering the competition, you agree and expressly permit to sign up to The MotherHood's mailing list.
4. The MotherHood employees and their respective relatives are excluded from entering the Competition. This includes subsidiary companies, as well as representatives and agents, of The MotherHood.
5. The prize draw is open to UK residents aged 21 years and over. You must be a resident within London and the boundaries of the M25.
6. The closing date for entries to the Competition is midnight (CET) on the **20<sup>th</sup> October 2016**. Late entries (i.e. entries received after the latter closing date) will not be accepted.
7. You must enter the Competition using your legal name. The MotherHood reserves the right to disqualify anyone entering into the Competition using a false name. By entering the Competition, You hereby warrant that all information submitted by You is true, current and complete.
8. If You provide an incorrect name, age, address or other incorrect information in relation to the Competition entry, then The MotherHood reserves the absolute right to treat that entry as invalid. If the fraud, deceit, misconduct or other action is only discovered after the Prize has been released, You undertake to return the same (or provide compensation) to The MotherHood forthwith upon notification by The MotherHood.
9. The MotherHood reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these Terms.
10. The MotherHood reserves the right to immediately withdraw Your place on the Competition or the Prize if it believes You to be in breach of any of Your obligations, or representations and warranties under these Terms or if You otherwise conduct Yourself in a manner which is inappropriate or unsuitable (as determined in the sole discretion of The MotherHood).
11. Any costs associated with accessing the The MotherHood website, Facebook page, or Email, is Your responsibility and is dependent on the internet service provider used.
12. Since The MotherHood is principally aiming the Competition at residents of the United Kingdom, The MotherHood cannot guarantee that the Competition accords with the local laws of any other countries and jurisdictions. You are therefore responsible for compliance with the laws of Your own country and jurisdiction if You are outside UK (Europe). The MotherHood will not be held responsible if You enter the Competition unlawfully. You are not entitled to enter and participate in the Competition if You are resident in a country or jurisdiction where the Competition may breach any law or regulation.

## Choosing the Winner

13. The MotherHood will select the winners from among all the eligible Competition participants at random by such means and methods (which may be manual or computerized) as The MotherHood may in its sole discretion determine. Upon selection the participant shall become the winner of the Competition. In the event that:
  - o the participant so selected is disqualified for not meeting any requirement set out in these Terms;

- the winner does not contact The MotherHood within 48 hours since the winner has been contacted
- The MotherHood is unable to contact the selected participant within a reasonable period of such a participant having been selected;
- or, the winner is unable for whatever reason to accept the Prize;
- or, the winner does not claim the Prize within 28 days of notification by The MotherHood;
- then The MotherHood shall proceed to select another individual from among all the eligible Competition
